

**Dart Center – FY 26 Baseline Augmentation Request**

The Dart Center is requesting the following FY 26 Base Augmentation to help adequately support the implementation of access for students with disabilities, meet the growing demand for services and support compliance with the Americans with Disabilities Act. Justifications, cost breakdown and descriptions are included:

**Program Coordinator I (Alternative Testing Support) –**

**Impact:** Alternative testing services has seen a substantial increase in request from both students and faculty. The Dart Center currently serves all professional schools, including colleges in the facilitation of testing proctoring and ensuring students are receiving their approved accommodations. Having this critical position will allow the Dart Center to work to support additional hours, cut-down on wait time, improve communication and also better support the growing need at the Sugarland/Kay Instructional sites.
